UPON hearing counsel for the Claimant and for the Defendant.

AND UPON the Court having determined that the Claimant has attempted to mislead the Court by adducing written evidence from a purported independent witness to the accident whom the Court has determined was not present,

IT IS ORDERED THAT

1. Pursuant to section 57(2) of the Criminal Justice and Courts Act 2015 the Claimant's claim is dismissed on the ground the Claimant has been fundamentally dishonest in relation to his primary claim.
2. Pursuant to section 57(4) of the Criminal Justice and Courts Act 2015 it is recorded that, but for dismissal of the Claimant's claim by reason of fundamental dishonesty, the Court would have awarded the Claimant the sum of £1425.00 representing 25% of the value of the Claimant's claim, it being the Court's determination that the Defendant was 25% responsible for the happening of the accident and the Claimant 75% responsible.
3. The Claimant shall by 4pm 1st June 2016 repay to the Defendant the interim payment of £1145.00.
4. The Claimant shall pay the Defendant's costs of the action on the indemnity basis such costs to be subject to detailed assessment if not agreed. Pursuant to CPR Part 44.16 the Defendant has permission to enforce such costs as are agreed/assessed. The Defendant shall be responsible for the costs of any detailed assessment proceedings.
